

Terms and Conditions of Participation – Exhibitors

These conditions apply to participation in the **BAU Info Talks on 15 and 16 October 2021**.

General

- The participation at the BAU Info Talks is limited to confirmed exhibitors of BAU 2021!
- As capacity is limited we have to restrict the number of participants in the BAU Info Talks.
- Exhibitors will be registered on a first-come, first-served basis.
- Filling in and sending off the online form is regarded as a binding registration to the BAU Info Talks.
- On receipt of your registration, you will receive by return a confirmation e-mail, containing further information. If, however, the maximum number of participants has been reached, you will be sent an e-mail informing you of this.
- The deadline for receipt of registrations is 18 September 2020.
- Messe München will place exhibitors participating in the Talks in alphabetical order in Hall C6.
- About two weeks before the event starts, you will be sent a further e-mail containing all the key information about the event.
- Attention: Should the current distance regulation (1.5 metres) due to the COVID 19 pandemic continue until October, we may limit participation to one person per exhibitor.

Participation fee

- A maximum of two people from each participating exhibitor are permitted to take part in the BAU Info Talks.
- The charge for participation is a one-time fee of 600 Euro.
- In return for the participation fee, Messe München will make available at the Info Talks on 15 and 16 October 2020 a table with company sign, an electricity connection and wlan. Because space is restricted it is not possible for exhibitors to design their space individually (no roll-up displays!).
- The participation fee also covers food and drink during the event (welcome snack, midday buffet, beverages).
- The participation fee will be charged to participating exhibitors on their final invoice for BAU 2021. No separate invoices can be issued, nor can we invoice any agencies you may commission.

Evening event

As part of the BAU Info Talks we invite all participants to an evening event on 15 October 2020. Please indicate on your registration form if you will be taking part in this evening event.

Cancellation of participation

Exhibitors wishing to cancel their participation can do so without incurring costs up to 18 September 2020. In the case of cancellations after this date, the full participation fee will be invoiced.

Cancellation of the event

In case that the BAU Info Talks in CCN/Hall C6 have to be cancelled due to the COVID 19 pandemic, BAU will try to implement an online alternative. In this case the registration remains valid. In case of a complete cancellation the participation fee will not be charged.

Passing on of data

By consenting to the Terms and Conditions of Participation the exhibitor consents to his/her data (name, company name, country, e-mail address, telephone number) being made available to the other event participants, comprising around 150 exhibitors and 150 trade journalists. The data may only be used within the framework of the BAU Info Talks. Data may not be passed on to third parties.
